W.P. No. 23361 (W) of 2014 Sri Debdas Sarkar & Ors. Vs

The State of West Bengal & Ors.

Dipankar Datta, the case was considered.

A hearing was held on 18.11.2014. The petitioners attended the hearing. Ld. Advocate pleaded on behalf of the petitioners.

- 3. Ld. Advocate claimed that his clients are entitled to "A" category scale of pay due to their obtaining Certificate in respect of PTT Examination conducted by the West Bengal Board of Primary Education. He also submitted that their training session was held from 01.07.2005 to 30.06.2006. But their Examination was held in February 2011 and their result was published on 14.07.2011. The Ld. Advocate also submitted that the persons similarly situated and circumstanced have already been given benefit in the district of Hooghly by the District Primary School Council, Hooghly in terms of the G.O. No. 389 (38)-SE (E) dated 13.08.2012.
- 4. Having considered the facts and circumstances of the case, it is found:-
  - (a) That the petitioners were appointed to the service before 03.09.2001 but they obtained 1 Year PTT certificate on 14.07.20111 i.e., after 31.12.2005.
  - (b) It appears from Note-2 under first Schedule of the National Council for Teacher Education (Determination of Minimum Qualifications for Recruitment of Teachers in Schools) Regulation 2001 dated 4th September, 2001 published in terms of F-No. 9-2/2001/NCTE dated 03.09.2001 that with the promulgation of the National Council for Teacher Education Act, 1993 read with the National Council for Teacher Education (Determination of Minimum Qualifications for Recruitment of Teachers in Schools) Regulation 2001, Primary Teacher's Training degree or diploma for I year duration after 31.12.2005 is not a valid certificate as per NCTE Norms.
  - (c) Since, the petitioners obtained 1 year PTT Certificate after 31.12.2005, the School Education Department, Government of West Bengal is not in a position to recognise the said one Year Primary Teacher Training Certificate.

- (d) Since, "A" category Scale of Pay is allowed to a Primary School Teacher under the District Primary School Council who possesses at least Madhyamik or equivalent academic degree alongwith Teacher Training Certificate as per NCTE norms, the petitioner cannot be allowed "A" category Scale of Pay as per their claim as their training certificate is not upto the mark as per NCTE, rules.
- (e) It is not consistent that persons similarly situated and circumstanced enjoying the benefit of "A" Category Scale of Pay have been allowed by some District Primary School Councils in terms of the G.O. No. 389 (38)-SE (E) dated 13.08.2012. There is no such provision in the said G.O. to allow such benefit to the teachers obtained 1 year PTT Certificate after 31.12.2005. The Commissioner of School Education, West Bengal is requested to communicate this decision to all concerned.

Thus, the matter is disposed of. All concerned be informed accordingly.
