## NOTICE FOR REGISTRATION OF RESIDUAL UNTRAINED IN-SERVICE PRIMARY SCHOOL TEACHERS APPOINTED ON OR AFTER 03.09.2001 INTO THE TWO YEAR D.El.Ed. COURSE-2015-17 THROUGH ODL-MODE

In continuation of our notification no. 278/1(41)/BPE/2016 dt. 03.03.2016, this is to further notify for information of all concerned that the process for the registration into Two Year D El Ed course (through ODL-Mode)-2015-17 for the in-service **Residual** Untrained Primary School Teachers is to commence in terms of the order of the Government of West Bengal in the Department of School Education, No 129-SE (EE) /10 M-14/16, Date: 16/2/2016, read with the approval-order of the NCTE No. F.62-3/2011/NCTE/N&S, Date: 24/04/2015 and subsequent clarifications in November-2015.

The **Residual** in-service eligible untrained Primary School Teachers are requested to register themselves for the Two Year D.El.Ed. course (through ODL-Mode)-2015-17 with effect from 06/04/2016 to 19/04/2016 in their respective District Primary School Councils or Primary School Councils on payment of 500/- (five hundred) only by a Demand Draft, drawn on United Bank of India (UBI), payable to West Bengal Board of Primary Education. Essential conditions of eligibility for registration into the said course are:

- I. The applicant should be working as a primary teacher against a sanctioned post. Such an appointment should be made on or after 03-09-2001
  - a) A primary school teacher appointed prior to 03-09-2001 shall not be considered as 'residual' and therefore, shall be treated as 'not eligible' for registration into the course
  - b) A primary school teacher, appointed between 03-09-2001 and 31-12-2005 and having passed one year or two year diploma/certificate in Primary Teacher Training, by whatever name it may be known, within 31-12-2005, shall not be considered as 'residual' and therefore, shall be treated as 'not eligible' for registration into the course
- II. Must pass H.S. or its Equivalent Examination with 50% ( for unreserved category teachers) or with 45% (for reserved category teachers, such as SC/ST/OBC-A/OBC-B/ PH/ Ex-servicemen/Exempted Category)

Or

Must be a graduate from a recognized university irrespective of the percentage of marks therein


III. In case of

- a. not having passed the H.S. or its equivalent examination with 50% or 45% (as the case may be)
- b. not being a graduate from any recognized university
- c. being a Madhyamik-pass teacher

the applicant teacher must have registered himself/herself with the West Bengal Council of Rabindra Open Schooling (WBCROS) or National Institute for Open Schooling (NIOS) for upgradation . In such cases, he/she shall have to put in the registration/enrolment number at the time of registration.

This is further to inform all concerned that

- i. The Two Year D.El.Ed. course (through ODL-Mode)-2015-17 for the in-service residual teachers will be conducted by West Bengal Board of Primary Education
- ii. Such a teacher undergoing the Two Year D.El.Ed. course through ODL mode may simultaneously upgrade his/her minimum academic qualification for the course or percentage of marks in the H.S. or its equivalent examination through either WBCROS or NIOS. But she/he will not be declared to have passed the training course, unless and until she/he attains such minimum qualifications for the course through up-gradation.
- iii. the registered teachers will be informed of their study centres through the concerned S.I. of Schools
- iv. Such registered teachers will be provided with the printed study materials for the course through the concerned District Primary School Council or the Study Centre




